

## CALL FOR AWARDING RESEARCH FELLOWSHIPS WITHIN PROJECT GRANTS AND R&D INSTITUTIONS

1 (one) Research Fellowship (BI) for a MSc Student or a BSc enrolled in a non-degree course

1 Research Fellowship(s) (BI) is(are) open at the **FCiências.ID – Associação para a Investigação e Desenvolvimento de Ciências**, for the project/R&D institution "CEAUL", "UIDB/00006/2020", "DOI: <a href="https://doi.org/10.54499/UIDB/00006/2020">https://doi.org/10.54499/UIDB/00006/2020</a>", funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funds (PIDDAC) under the programme Projeto Estratégico, under the following conditions:

- Scientific Area: Ecological Statistics
- 2. Admission requirements: A Bachelor degree in statistics or biological sciences.

  Proficiency in Portuguese (spoken and written), in the European variant of Portugal, at level C2 of the Common European Framework of Reference for Languages, certified with the respective diploma, or as a mother tongue, since, as per the work plan, will produce outputs in Portuguese, the European variant of Portugal, and it is essential that the candidate is able to produce written reports and oral presentations in Portuguese.
- 3. Additional optional skills and qualifications: Proficiency in statistical modelling in the R environment, namely using GLMs and GAMs. Previous experience in the analysis of cetacean data which will be the subject of a significant component of the work plan, a per below.
- 4. **Contracting requirements**: Presentation of the academic qualifications and/or diplomas. Enrolment in master or non-degree course developed in association or cooperation between a High Education Institution and one or multiple research units.
- 5. **Work plan**: Analysing demographic data for the Sado Estuary bottlenose dolphin population. Writing at least a publication based on spatial density surface models of cetaceans. Research support in the CEAUL project Dados Contados (within a protocol with RTP).

- 7. **Place of work**: The work will be developed at the CEAUL, FCUL under the scientific supervision of Professor Tiago A. Marques.
- 8. **Fellowship duration**: This position is initially opened for 3 months due to start in November 2024. The fellowship contract may be potentially renewed for 3 months.
- 9. **Monthly allowance**: The fellowship amounts to €990,98, according to <u>table values</u> of the fellowships awarded directly by the FCT, IP. The fellowship holder will have a personal accident insurance and can ensure the right to social security through adherence to the voluntary social insurance scheme, if not covered by any other social protection scheme, pursuant to *Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social*. The fellowship will be paid monthly by bank transfer.
- 10. **Evaluation and selection process**: Candidates will be assessed by a motivation letter (20%) and a CV (80%), which will be evaluated under the light of the adequacy of the candidate's experience for the work plan proposed.

Applicants whose application is scored with a final classification of less than 50 points are not eligible for granting a fellowship.

- 11. **Selection Committee**: Tiago A. Marques (President of the jury); Lisete Sousa and Marilia Antunes (effective members); Soraia Pereira and Rui Martins (alternate members).
- 12. **Publication/notification of results**: All the candidates will be notified by e-mail, sent by the call holder, with the selection meeting minutes enclosed.
- 13. **Deadlines**: This call for applications is open from 17/10/2024 to 30/10/2024.
- 14. **Application:** Applications should be sent via e-mail to ceaul@ciencias.ulisboa.pt, by attaching the following documents:
  - a. Curriculum vitae;
  - b. Certificate of completion of previous degree Note 1, 2;
  - c. Motivation letter;
  - d. Certificate of Portuguese Level (for non-native speakers only).
- 15. **Processing of personal data:** FCiências.ID Associação para a Investigação e Desenvolvimento de Ciências, as the controller under the General Data Protection Regulation, collects and processes the personal data requested in the context indicated in paragraph 14., under the legitimate interests in ensuring the award of the research fellowship to candidates with the indicated profile.

- 16. **Time limits for the appeal procedure:** In case of negative decision, the candidates have 10 business days, after the date of announcement of the results of the candidates' evaluation, to pronounce their disagreement in accordance with the *Código do Procedimento Administrativo*. Appeals against the final decision may be submitted to the Administration Board of FCiências.ID (<a href="mailto:fciencias-id@fciencias-id.pt">fciencias-id@fciencias-id.pt</a>) within 15 business days after the notification date.
- **Note 1:** The documents that prove the entitlement of the academic qualifications and diplomas can be dismissed during the application period and replaced by a declaration on their honour from the applicant (Minuta PT, Minute EN). Their delivery is mandatory for the fellowship contractualization.
